

## FINANCIAL DISCLOSURE STATEMENT FILING NOTIFICATION FOR CANDIDATES RUNNING FOR OFFICE IN 2025

As a candidate in 2025 for any of the following elected offices, you are required by Ohio law to file a personal financial disclosure statement (FDS) for <u>calendar year 2024</u> with the Ohio Ethics Commission.

- State elected offices
- School district board of education (district with 12,000 or more students)
- County elected offices
- ESC governing board member (ESC with 12,000 or more students)
- City elected offices

(Ohio law does not require candidates for township or village elected offices to file financial disclosure statements.)

<u>Exceptions</u>: Candidates for the Ohio General Assembly file with the Joint Legislative Ethics Committee and candidates for judicial office file with the Ohio Board of Professional Conduct.

The personal financial disclosure requirement is SEPARATE from a candidate's requirement to file campaign finance reports. You must file a financial disclosure statement regardless of whether you have raised or spent money on your campaign. It is your responsibility to access, complete, and file the statement by the deadline that applies to you. Any person who files the disclosure statement after the appropriate deadline is required to pay a late fee of \$10 a day for each day the statement is late. The maximum late fee is \$250.

## **CANDIDATE FILING DEADLINES:**

For most candidates\*, the statement is due **30 days before the first election** when your name appears on the ballot. For write-in candidates, the statement is due 20 days before the first election at which your candidacy will be voted upon.

<sup>\*</sup>Incumbents: If you will also be a candidate in 2025 for the same office or any other elected office which would require you to file a calendar year 2024 financial disclosure statement <u>and</u> are certified to a ballot prior to May 15, 2025, you are required to file 30 days (20 days for write-in candidates) before the first primary, special, or general election when your name will appear on a ballot. If you are not certified to a ballot prior to May 15, 2025, you must file by May 15, 2025.
